The Distinguished Toastmaster (DTM) award is the highest achievement within Toastmasters International. The DTM recognizes a member of Toastmasters who has displayed a consistent superior level of achievement in both communication and leadership.



Distinguished Toastmasters are a rare breed. Less than 1% of all Toastmasters ever achieve that designation. Sears-Halifax has added *another* DTM to our list of

achievers, Tracy Gatis! Congratulations!!! We are proud of you!



I completed my first Pathways level in November. The path I chose to follow is "Presentation Mastery". I had to complete three speeches and an evaluation. This is already much different from the "Toastmasters Legacy Program" which I completed the year before. The Legacy CC manual guided you speech by speech through how to improve specific aspects of your speaking skills (gestures, vocal variety, etc.). In contrast, the pathway that I am on does not address these specifics. The Legacy CC had no requirement to do an evaluation. That step, among others not directly related to speaking, was left to the leadership program.

There have always been conflicting viewpoints on how many speeches should be done before someone starts to evaluate. In our club, a rough rule of thumb seemed to be about a 1/2 dozen or so, but there were always dissenting voices saying that evaluations should be done as soon as possible. Pathways has opted for the latter - you do an evaluation after your Icebreaker! My own opinion on this is that it is asking too much of a new person to evaluate someone else when they are still learning the ropes themselves. Obviously some people will have no problem with it, however others will feel that this step is too high, too soon, and it will drive them away.

Pathways is a very different approach from the old system. Clearly the old system was not getting people through reliably enough, and something had to be done to improve matters. Pathways was the answer to this problem. Will it be a success? Only time will tell.

Another Amazing Engineer

Henry Martyn Robert

Leave it to an engineer to get things right. Back in 1863 at age 26, Henry Robert was chair of a meeting that reportedly lasted 14 hours and accomplished nothing because the assembly did not "behave itself". Afterward he was determined to not let something like that happen again, so he tried to find guidance from existing

material on parliamentary procedure. He was not satisfied with what was available, so he prepared his own 16-page guide which he was not able to complete until 1874. However, he had difficulty getting it published because no publisher believed that a non-lawyer-engineer would be qualified to provide such guidance.

He finally had to take the financial risk himself and 4,000 copies were produced in 1876. As we say, the rest is history and critics suggested that a lawyer could not have produced such work because it would have become bound by existing rules and precedents.

Over the next 40 years Roberts' worked on fine tuning his rules and in 1915 published "Robert's Rules of Order Revised" which is the basis for today's versions.

His son, Henry Robert Junior and grandson, Henry Robert III carried on with the subsequent revisions. The latest is the 11th edition, *"Robert's Rules of Order Newly Revised"*, published September 2011.

There is also a second version of the "Robert's Rules of Order Newly Revised in Brief" available; which is a compressed version of the main book. These can be purchased at any bookstore.

Also, there is the "Parliamentary Procedure at a Glance" booklet by O. Garfield Jones. I have made fun of this book in my secretary speeches as it seems to be written in its original 1932 style although it is supposed to have been revised several times.

General/Engineer Robert once said, "When a better book comes along, get behind it." After doing the research for this article I am encouraged to order the official Robert's version.


